*Short certificates of baptism are not issued as the Baptismal Registers Measure 1961 does not extend to the Isle of Man.*

*Under the Baptismal Fees Abolition Act 1872 no fee may be charged for a service of baptism.*

#### *NOTES*

*No fee is payable in respect of a burial of a still-born infant, or the funeral or burial of a person dying under the age of 16.*

*Fees due to the DBF may be waived only with the written permission of the Archdeacon on behalf of the DBF. Fees due to the PCC may be waived only with the consent of the PCC.*

#### *Definitions:*

*'burial' includes the opening of a vault or grave, deposit in a vault or brick grave and the interment or deposit of cremated remains;*

*'parish burial ground' includes a churchyard and any other burial ground maintained by the churchwardens of a parish whether or not adjoining a church; it also includes any area used for the interment of cremated remains within such a churchyard or burial ground, whether consecrated or not;*

*'monument' includes headstone, cross, kerb, border, vase, chain, railing, tablet, plaque, flatstone, tomb, tombstone or other memorial of any kind;*

*'immediately preceding or following on from service in church' means on the day before, the day of, or the day after the service in church;*

*'on separate occasion' means on a day other than the day before, the day of, or the day after the service in church.*

### **Note on local charges for 'Extras'**

1. The fees shown in this table do not include charges for heating, the services of a vergers, music (e.g. organist, choir, cost of sheet, streamed or recorded music), bells and flowers, which are fixed by the PCC or the service provider (e.g. musicians or flower arrangers). The PCC must spell out what any extra charge is for; a charge must be reasonable and specific. A general charge, e.g. a "facility fee", may not be charged.
2. The minister should discuss the statutory fees and all other charges with those concerned *in advance of the service* and ensure that the person paying the charges understands what they will be. A table of local charges should be displayed alongside this Table of Fees.
3. *Matters included in the fee* In the case of a wedding or funeral service in church, any costs and expenses incurred in respect of routine administration (including arranging dates and times and the making of entries in registers), the cost of the parish clerk, making the church available, cleaning and lighting are included in the fee prescribed as payable to the PCC.
4. *Mileage* In the case of a wedding the minister claims any mileage against the PCC, and this is included in the PCC fee: the couple pay no extra. In the case of a funeral, the minister should claim the mileage direct from the funeral director in arrear when presenting the invoice.
5. *Payment in advance* A PCC may resolve that any local charges are to be paid in advance of the wedding, and may decline to provide the "extras" if the charges have not been paid at the time of the service. However, the statutory fees in this Table cannot be demanded in advance.
6. *Further guidance* Reference may be made to the *Guide to Church of England Parochial Fees* which can be found online. N.B. The Guide is based on English law and English fees which are different but the general principles on "Extras" apply.
